Page 1, Para 1	Tenders are hereby invited for the work of from contractors of appropriate class of CPWD, Railways, MES, Post & Telegraph Department and / or from those who have carried out similar works for CSIR and Semi-Govt. Organisations amounting to Rs.....(Rupees..... only) and above. The tenderers are required to produce proof of fulfilling these conditions alongwith latest Income Tax Clearance Certificate while making request for issue of Tender documents.	Tenders are hereby invited for the work of in two envelopes system from eligible contractors of appropriate class of CPWD, Railways, MES, Post & Telegraph Department and / or from those who have carried out similar works for CSIR and Semi-Govt. 4.	Page 1 Para 6	Tenders should be submitted in double sealed covers superscribed with the name of work, date and time of opening written both on the inner & outer envelopes. They will be received upto 3.00 P.M on and will be opened at 3.30 P.M on the same day in the office of Tender should be dropped in the tender box before the closing date and time indicated. In case these are sent by post, these should be sent by Regd.post/speed post addressed to..... Tenderers are to ensure that they post the tender well in advance so as to reach before the closing time and date indicated.	Tenders should be submitted in double sealed covers superscribed with the name of work, date and time of opening written both on the inner & outer envelopes. Eligibility documents and Financial Offers should be given separately in two sealed envelopes each marked with 'Eligibility Documents' and 'Financial Offer' respectively. Envelope1 marked as 'Eligibility Documents' should contain Covering letter with prescribed annexure as referred above, Cost of Tender and Earnest Money and Envelope2 marked as 'Financial Offer' should contain tender documents along with price bid. Both the envelopes shall be submitted together in another sealed envelope. They will be received upto 3.00 P.M on and will be opened at 3.30 P.M on the same day in the office of Tender should be dropped in the tender box before the closing date and time indicated. In case these are sent by post, these should be sent by Regd.post/speed post addressed to..... Tenderers are to ensure that they post the tender well in advance so as to reach before the closing time and date indicated. The envelope marked as 'Eligibility Documents' shall be opened at the same day. The time and date of opening of Financial Offer of only the qualified

Page 1 Para 8	The Employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.	<p>The Employer reserves the right to accept or to reject any tender, to annul the process and reject all tenders at any time without assigning any reason or incurring any liability to the tenderers. The Employer also reserves the right to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.</p> <p>The Employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.</p> <p>The Employer also reserves the right, without being liable for any damages or obligation to inform the tenderer, to:</p> <ol style="list-style-type: none"> a) Amend the scope and value of contract to the tenderer b) Reject any or all the applications without assigning any reason.

Page 2 Para 15	Earnest Money will be forfeited if the contractor fails to commence the work as per letter of award.	<ol style="list-style-type: none"> a) If any tenderer withdraws his tender before the expiry of the validity period, or before the issue of letter of acceptance or work order, whichever is earlier, or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the employer shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the earnest money absolutely. b) If the contractor fails to furnish the prescribed performance guarantee within the prescribed period, the earnest money will be absolutely

			<p>forfeited to the employer.</p> <p>c) In case the contractor fails to commence the work specified in the tender documents or such time period as mentioned in the letter of award, after the date on which employer issues written orders to commence the work, or from the date of handing over of the site, whichever is later, the employer is at liberty to forfeit whole of the earnest money absolutely.</p> <p>d) If only a part of the work as shown in the tender is awarded, and the contractor does not commence the work, the proportionate earnest money with respect to cost of work so awarded will be forfeited</p> <p>In case of forfeiture of earnest money as above, the tenderer shall not be allowed to participate in re-tender of the work.</p>

Page 2 Para 17(c)	<p><u>Already amended provision in condition of contract for works in CSIR</u></p> <p>A sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with the sum already deposited as earnest money, will amount to security deposit of 5% of the tendered value of the work.</p> <p>In addition, the contractor shall be required to deposit an amount equal to 5% of the tendered value of the contract as Performance Security within the period prescribed for commencement of work in the letter of award issued to him.</p>	<p>A sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with the sum already deposited as earnest money, will amount to security deposit of 5% of the tendered value of the work.</p> <p>In addition, the contractor shall be required to deposit an amount equal to 5% of the tendered value of the contract as Performance Security within the period prescribed for commencement of work in the letter of award or the period prescribed for deposition of performance security in the letter of intent issued to him whichever is earlier.</p>
